NEW BUSINESS

9. <u>10/1/2015 Actuarial Valuation Results</u> – Kelly Adams of Gabriel Roeder Smith submitted the annual Actuarial Valuation for 10/1/15. With the report complete, Ms. Adams reminded the Board that the valuation determines the required City and State contribution for the fiscal year ending 9/30/2017 as well as other necessary accounting information. The Board discussed cash needs and liquid investments of the Plan. Steve Cypen also suggested that the Board look into the payroll that determines the supplemental fire award from the State. There may be items that are not captured that would increase

the amount owed to the Fire department. Below are some highlights from the report.

Contribution requirements:

Member: \$ 2,655,620 State: \$ 2,470,921 City: \$ 24,884,886 Total: \$ 30,011,067

- Last year City contribution \$23,719,361
- Actuarial loss of \$4,114,818:
- Market value return of 2.0%.

Motion by Gary Arenson, second by Vicki Minnaugh, to accept the 2015 Actuarial Valuation as presented by Ms. Adams of Gabriel Roeder Smith. The motion carried unanimously.

- 10. <u>F/F COLA effective 4/1/2016</u>: Chairman Cabeza presented the list of COLAs for eligible retired firefighters and beneficiaries effective with the 4/1/2016 benefit payments. <u>Motion by Gary Arenson, second by Jack McCluskey to approve Firefighters COLAs effective 4/1/16</u>. The motion carried unanimously.
- Herndon Fee Proposal: Herndon Capital submitted a new proposed fee scheduled in an attempt to alleviate some of the Board's concerns about performance. Consultant Greg McNeillie explained how the fee schedule would work and when an incentive for performance would apply. Motion by Gary Arenson, second by Vicki Minnaugh, to accept a voluntary reduction to 25 basis points with no incentive until further notice. The motion carried unanimously. Mr. McNeillie promised to discuss the motion with Herndon and they would be ready to report back at the May meeting.
- **12.** <u>Fire Trustee Mid-Term Election:</u> Asst. Administrator Maldonado submitted a timetable for the election to fill Trustee Musumeci's seat when he vacates it in May.
- 5 affidavits outstanding. The initial letter had been sent at the end of January. Ms. Maldonado and Mr. Fisher had then contacted close to 50 individuals via telephone after the due date elapsed. All subsequent affidavits were returned except for the last five. The Board asked the office staff to issue a second and final notice to collect via certified mail. If those individuals do not respond, the benefit will be suspended beginning May 1st and continue until such time that the affidavit is received.

14. <u>Computers R Us Proposal</u>: The Board discussed the proposal with Jack Sanders. <u>Motion by Adam Feiner, second by Kevin Venema, to move forward with tablet purchase, with the addition of extended warranty purchases for each tablet. The motion carried unanimously.</u> Mr. Sanders will put the additional warranty purchase on the invoice and send an updated invoice to the office staff for payment.

15. Reports:

<u>Actuary</u> – Ms. Adams informed the Board of the current projects GRS is completing for Pembroke Pines, which include: DROP accounting for the quarter ending 12/31/15, the Plan's annual report, an SPD update, and the annual benefit statements.

Attorney – No additional report at this time.

<u>Chairman</u> – The Board changed the August meeting date to August 11, with the meeting beginning at 11:00 AM. He also reminded the Board the NCPERS annual conference is scheduled in May.

<u>Plan Administrator</u> – The Asst. Administrator notified the Board that a disability application was recently received and she will begin the processing of the application.

Administrator Fisher officially notified the Board of the recent passings of two of its members: F/F Joseph Montopoli and P/O Michael Hones. The office has already set up their respective beneficiaries in accordance to their retiree records.

MEMORANDUM OF VOTING CONFLICT FOR

WHO MUST FILE FORM 8B

This form is for use by any person serving at the county, city, or other local level of government on an appointed or elected board, council, commission, authority, or committee. It applies equally to members of advisory and non-advisory bodies who are presented with a voting conflict of interest under Section 112.3143, Florida Statutes.

Your responsibilities under the law when faced with voting on a measure in which you have a conflict of interest will vary greatly depending on whether you hold an elective or appointive position. For this reason, please pay close attention to the instructions on this form before completing the reverse side and filing the form.

INSTRUCTIONS FOR COMPLIANCE WITH SECTION 112.3143, FLORIDA STATUTES

A person holding elective or appointive county, municipal, or other local public office MUST ABSTAIN from voting on a measure which inures to his or her special private gain or loss. Each elected or appointed local officer also is prohibited from knowingly voting on a measure which inures to the special gain or loss of a principal (other than a government agency) by whom he or she is retained (including the parent organization or subsidiary of a corporate principal by which he or she is retained); to the special private gain or loss of a relative; or to the special private gain or loss of a business associate. Commissioners of community redevelopment agencies under Sec. 163.356 or 163.357, F.S., and officers of independent special tax districts elected on a one-acre, one-vote basis are not prohibited from voting in that capacity.

For purposes of this law, a "relative" includes only the officer's father, mother, son, daughter, husband, wife, brother, sister, father-in-law, mother-in-law, son-in-law, and daughter-in-law. A "business associate" means any person or entity engaged in or carrying on a business enterprise with the officer as a partner, joint venturer, coowner of property, or corporate shareholder (where the shares of the corporation are not listed on any national or regional stock exchange).

ELECTED OFFICERS:

In addition to abstaining from voting in the situations described above, you must disclose the conflict:

PRIOR TO THE VOTE BEING TAKEN by publicly stating to the assembly the nature of your interest in the measure on which you are abstaining from voting; and

WITHIN 15 DAYS AFTER THE VOTE OCCURS by completing and filing this form with the person responsible for recording the minutes of the meeting, who should incorporate the form in the minutes.

APPOINTED OFFICERS:

Although you must abstain from voting in the situations described above, you otherwise may participate in these matters. However, you must disclose the nature of the conflict before making any attempt to influence the decision, whether orally or in writing and whether made by you or at your direction.

IF YOU INTEND TO MAKE ANY ATTEMPT TO INFLUENCE THE DECISION PRIOR TO THE MEETING AT WHICH THE VOTE WILL BE TAKEN:

• You must complete and file this form (before making any attempt to influence the decision) with the person responsible for recording the minutes of the meeting, who will incorporate the form in the minutes. (Continued on other side)
